### 1. Membership Classification

All membership classifications, qualifications for membership in each classification, and the respective initiation fees and dues charges have been presented to me with this application. I understand that dues and other charges are subject to periodic adjustment.

### 2. Membership Term and Cancellation

I understand that this agreement to share meeting space is for a minimum term of 6 months (unless I have opted for the Open Rate program). Should I decide to cancel prior to the end of the agreed term, I will be charged the difference in the rate between the Open Rate and the term that I had agreed to originally. I may cancel this agreement with Studio C, by giving 30 days advance written notice to Studio C and by paying any dues and other charges for which I may be liable and I shall not thereafter be subject to any further dues or other charges. Initiation fees are non-refundable.

### 3. Shared Resource Agreement

I understand that Studio C is a shared resource space and that my right to use Studio C services and facilities are coequal with the rights of other business people sharing Studio C.

#### While at Studio C, I agree to the following:

Dress code is professional attire. Torn jeans, extreme casual attire, flip flops, sandals, shorts, and cutoffs are examples of inappropriate attire.

Reasonable discretion of use of shared meeting space resources (herein after referred to as "resources"). I will not unfairly monopolize the resources to the detriment of others.

Public Address systems will be used only upon approval of Studio C at levels that do not disrupt the other tenants of the surrounding spaces.

Professional conduct. I will conduct myself in a professional and courteous manner.

I will observe and follow the reasonable and nondiscriminatory policies that may be put forth by Studio C from time to time to keep the space a happy experience for all.

I understand that Studio C reserves the right to discuss any deviation from these policies with me and can then terminate our agreement if the policy continues to be ignored, abused, or disregarded by me. (In other words, don't make us get out the flying monkeys)

I understand that I am responsible for the behavior and conduct of my guests while they are in the shared workspace of Studio C.

### 4. Limitations of Liability

In consideration of the shared meeting space agreement granted hereunder, I accept the shared meeting space resources "as is" and agree that all use thereof shall be undertaken at my sole risk. I shall indemnify, defend, and hold Studio C and The Gustin Group, its officers, members, managers, directors, employees, agents, and contractors harmless from and against any and all costs, charges, expenses, injuries, damages, liabilities, claims, suits, and actions, including, without limitation, attorney's fees and court costs

(collectively "Liabilities"), arising, directly or indirectly, from my shared meeting space agreement with Studio C. This includes, without limitation, my use, or the use by any other person acting as my guest, of any of the shared meeting space resources, or relating to any of my property, including without limitation, phones, computers, clothing, handbags, briefcases, information, trade secrets, or data (collectively "Property"), or that of my family or guests or persons under my care while at Studio C, which Property is lost, damaged, disclosed, or stolen at Studio C, except to the extent from resulting from gross negligence or willful misconduct on the part of Studio C, its officers or agents. I, personally and on behalf of my executors, administrators, successors and assigns expressly forever release and discharge Studio C and The Gustin Group, Inc., its officers, successors, assigns, managers, members, directors, employees, agents, and contractors from Liabilities.

### 6. Late Fees

I understand that, in the event that I fail to pay my membership dues or any other amounts owed in full within five (5) days following the date the same are due, Studio C shall have the right to charge, and I shall pay, a late fee equal to 18% of any amount outstanding.

### 7. Agreement to Terms

I have read and understand this Shared Meeting Space Agreement. By signing this agreement, I represent and warrant to Studio C that I have read and understand the terms of this agreement including, but not limited to those contained in Section 4 above. I have received a copy of Studio C Rules and Regulations as they exist on the date of this agreement, understanding that the same may be subject to amendment from time to time. I agree that while at Studio C, I am bound by such Rules and Regulations, as is any person at Studio C as a guest under my direction.
